#### Passenger Contract for 2016 WGBH LearningTour – An Irish Sojourn: Northern Lights

General Terms and Conditions

**Operator Agreement** This agreement sets forth the terms and conditions pursuant to which WGBH and Celtica Music & Tours (hereinafter referred to as "CMT"), in return for payment by the passenger of the amount specified as the trip price, agrees to provide the services and features as described in the tour brochure. Please read this agreement carefully before sending any money.

#### **Included in Cost of Program**

- Round-trip, economy class airfare from Boston to Shannon and back
- Private luxury motor coach transportation in Ireland
- Eight (8) nights of first-class hotel accommodations in rooms with private baths
- Nine (9) full breakfasts
- Eight (8) dinners
- Nightly live traditional music of Irish sessions
- · Admission to all group activities, sites and ferries
- Private guides for all activities mentioned in the itinerary
- Entrance fees for all scheduled museum and historic site visits
- Services of CMT tour operator and escorts throughout the tour
- All gratuities and taxes for hotels, meals and porters
- Baggage handling for one piece per person for WGBH/CMT arranged flight and coach

#### Not Included in Cost of Program

- Activities not offered as part of the tour
- Single-room upgrade if you are traveling alone and/or opt for a single room, add \$600 for eight (8) nights. Note: to avoid this upgrade, ask us to assign you a roommate. If none is available, the single room fee must be charged.
- Personal expenses and purchases, including alcoholic beverages not included in group meals
- Travel insurance covering medical emergencies and trip cancellation (highly recommended)
- Lunches

Reservations and Method of Payment The deposit for the tour is \$1,600 per person, and includes a \$600 tax-deductible contribution to WGBH. WGBH will accept payment by check, made out to WGBH Educational Foundation, or credit card (MasterCard, Visa, American Express or Discover). Please reserve early, as this tour will sell out quickly. Full payment is due Monday, June 6, 2016. The deposit is non-refundable.

Please complete the tour reservation form to accompany your payment and mail to: WGBH, One Guest Street, Boston, MA 02135, Attn: Sandy Chin. Upon receipt of deposit, WGBH will send a letter of confirmation and travel insurance information. Prior to departure, additional items of interest will be mailed to the participants. If you have any questions, please contact WGBH at 617-300-4400. A pre-departure reception will be arranged and hosted by WGBH for all participants. Please note that tour participation is limited to 30 participants or as space allows.

All payments should be made payable to WGBH Educational Foundation.

**Rates** Prices quoted are based on fares in effect at the time of printing and may be subject to change prior to departure. Prices could increase in the event of severe currency fluctuations or in the event of significant increases in airline taxes and surcharges, once these prices are established. If the Euro exceeds \$1.30 there may be an adjustment in the price of the tour. Participants will be notified of any such price increase at least 30 days prior to departure. If the tour proceeds with less than the minimum participation (15 individuals), a surcharge may be applied.

**Cancellations** You are entitled to a full refund if the tour is cancelled by WGBH or CMT. If you should cancel, you are entitled to a refund, minus the \$1600 per-person administrative fee based on the following schedule. If written cancellation is received by WGBH before May 16, 2016: 50% refund on total program cost. On or after May 16: no refund. No refunds for any unused portion of the tour including, but not limited to, occasional missed meals or any missed sightseeing tours. Costs for promotion, staff, and other group expenses are not refundable.

CMT must strictly adhere to its cancellation policy to offset expenses incurred prior to the program commencement. Notice of withdrawal from the tour must be communicated to WGBH by fax at 617-300-4433 or by email: sandy chin@wgbh.org. Sandy Chin at WGBH will confirm all cancellations.

Ticketed passengers must return unused tickets and any other negotiable vouchers for an applicable refund to be processed. No refund will be given for any passenger who, for any reason, does not arrive for either airline or vehicle departure. No refund will be made for features the passenger opts not to use. Once travel begins, any change made by a passenger is the responsibility of the passenger. Cancellation/changes caused by accident or illness to a passenger does not constitute waiver of applicable fees. Refunds will be processed within 90 days of receipt of cancellation notice.

**Travel Insurance** Because cancellation policies are strictly enforced, we strongly recommend for your protection that you purchase trip cancellation insurance. Travel insurance also is highly recommended in order to protect participants who must cancel or interrupt their trip due to illness or injury. Trip cancellation insurance is available. Information will be sent after your reservation is received.

Itinerary or Program Modifications While every effort will be made to adhere to the tour itinerary as planned, WGBH and CMT reserve the right to modify the itinerary or programs at their discretion, as warranted by circumstances at the time of the tour, including the right to substitute hotels of similar quality. In the event of any changes, WGBH and CMT will work to substitute programs of comparable value.

**Transportation** Our coach will depart Shannon airport at 6:30 a.m. on October 3, 2016; so anyone making their own flight arrangements may need to travel a day early. Participants are responsible for booking alternative air travel. Participants arriving or departing on other dates or from other destinations will be responsible for meeting up with the group in Ireland and for any fees incurred by these arrangements.

Responsibility Disclaimer WGBH is not the tour operator. WGBH is not responsible for changes of flight times, fare changes, dishonor of airline or hotel reservations, delays, losses, injuries, inconveniences, cessation of operations, airline or tour operator bankruptcies, acts of God, or any other event beyond our control. WGBH acts only as agent for the participants with respect to travel services, and shall not be responsible for changes in flight times, fare changes, dishonor of airline, hotel or other reservations, injury, damage, loss of baggage, accidents, or for the acts or defaults of any person or entity engaged in conveying participants or in carrying out other arrangements of the tour. Further, WGBH and CMT shall not be responsible for losses or additional expenses of the participant due to sickness, weather, strife, civil unrest, acts of terrorism, quarantine, acts of God, or other causes beyond their control. The right is further reserved to decline or accept or to retain any person as a member of the tour should the person's health, actions, or general deportment impede the operation of the tour or the rights or welfare of the other participants. No refund will be made for any unused portion of the tour.

**Mobility and Fitness to Travel** Please note that there is a moderate amount of walking on this tour. Passengers requiring special assistance, including without limitation those who permanently or periodically use a wheelchair, must be accompanied by someone who is fit and able to assist them, and who will be totally responsible for providing all required assistance.

**Limitations** CMT reserves the right to decline or reject any passenger for the tour at any time. The air carrier, other service providers, and CMT reserve the right to substitute aircraft, vehicles, and accommodations without penalty.

**Force Majeur** In the case of any event not caused by the fault of CMT preventing the safe performance of this tour occurring before the embarkation of the passengers, CMT is entitled (giving as much notice as possible to the charterers) to cancel or terminate the tour, reimbursing the passengers with any sums already paid hereunder. In the case of such an event preventing the safe performance or continuance of the tour occurring after the embarkation of the passengers, CMT is entitled to terminate the tour, without further liability on their part.

**Law Applicable** The agreement between CMT and passengers is governed by the laws of the Commonwealth of Massachusetts.
